
## NOTICE OF SPECIAL TOWN MEETING OF THE ELECTORS OF THE TOWN OF LINCOLN

NOTICE IS HEREBY GIVEN THAT on Wednesday, November 28, 2018 immediately following completion of the public hearing on the proposed budget which begins at 5:30 P.M. at the Town Hall, a Special Town Meeting of the Electors called pursuant to Section 60.12(1)(c) of the Wisconsin Statutes by the Town Board for the following purposes will be held:

1. To approve the elected officials' salaries for the April 2019-2021 term pursuant to Section 60.32 of Wisconsin Statutes.
2. To approve the 2018 town tax levy to be paid in 2019 pursuant to Section 60.10(1)(a) of the Wisconsin Statutes.
3. To authorize the Town Board to obtain a short term loan not to exceed \$150,000 in case of emergency.

A Special Meeting of the Town Board will be held at the Town Hall immediately following the Special Town Meeting of the Electors to adopt the 2019 Budget.
